# PUBLIC WORKS DEPARTMENT STAFF REPORT

- Council reviewed a draft road budget with Treasurer Judy Edwards and Public Works Supervisor Bob Edmunds, Council provided direction on several items and an up-dated draft will be provided at the next meeting.
- Andrew Farnsworth provided Council with a spreadsheet outlining several options for consideration for funding the purchase of a grader and a loader and completing the Midlothian Road bridge replacement project. Council would like the second option to be used in the next draft of the road budget.
- Bob Edmunds provided a general road department update including a possible claim from Bell Canada with respect to Nipissing Road construction in the fall of 2013
- The draft tender for a grader and a loader was reviewed, including timelines. Council suggested that the documents be sent to known suppliers and that the tender be posted on the municipal website and electronic procurement web sites. A special Council meeting was set for April 22, 2014 to make a decision on this tender.
