NOW THEREFORE BE IT RESOLVED that the Township of Ryerson hereby agrees to enter into a three year agreement for the creation and deployment of the Almaguin Community Economic Development (ACED) Department with multiple regional partners. And further that the Township of Ryerson recognizes the Township of Armour as the lead applicant for the FedNor C.I.I.N.O application for assistance and agrees to contribute a minimum of \$30,000.00 over a three year term to support all costs associated with the ACED Department.
